We are thrilled to share with you that we will be continuing the **Career Pathways** courses with our juniors and seniors in the Architecture pathway this spring. We have been working alongside **El Camino College (ECC)** in offering these dual enrollment courses and will continue to do so this year. Students will be eligible to earn credits in the courses listed below.

Grade	SPRING 2019
11th	Arc 171 (Architectural 3D Illustration) 3.0 units
12th	Arc 199 (Computer Aided Architectural Drafting) 3.0 units

Students will earn both high school and college credit in their Architecture courses. Our very own DVD teacher, Ms. Katherine Simon, qualifies as an adjunct professor through El Camino College and will be the students' professor of record for the college class in addition to their high school class.

In order for students to receive their much deserved college credit, they will need to apply to El Camino College online (if they already have not) and all students must complete a Concurrent Enrollment form.

The teacher and counselors can aid students in this process as needed, and we hope to secure representatives from El Camino College to come to campus for support as well.

We will need the support of our families to get students enrolled.

To prepare students for applying, we need your help with the following:

- Please fill out the El Camino College Application Checklist
 - Students will use this while filling out the online application
- Please fill out the Concurrent Enrollment Form – **“Student Information”** and **“Parent Consent”** sections
 - Da Vinci will turn in these forms to ECC for families/students
- Students will need their Social Security number **to apply** (this links to financial aid in the future)
 - If you have any concerns about this, please contact your student's counselor
 - If for whatever reason a student does not have a social security number, please contact an administrator or a counselor for further details and information. Students **can** still enroll in the courses in this case.

Hello parents & guardians,



Your student is enrolled in the **Architecture Pathway** at Da Vinci Design. During second semester, each class is a dual enrollment college course, which means students can earn three college credits by completing this class in addition to their high school credit. The credits will be issued by El Camino College. There are no fees or additional coursework required to earn the credit. However, students must register with El Camino in order to process the credits.

Registration is a two part process described below:

1) Paper Registration - Please fill out the form titled "**11th and 12th Grade Concurrent Enrollment Application.**" Complete all items in **Section I and II**. Provide the student's Social Security Number in Section I. The **student** must sign in Section I, and a **parent** must sign in Section II. Students will need to turn in both forms during class by **December 3rd**.

2) Online Registration - This will be completed **during December 3rd/4th** depending on what day their class falls on. In order for your student to be prepared for this online registration, please complete the form titled "El Camino College Community College District." The online process requires all the information on this page, including Social Security Number. (SSNs will be used for registration only and will not be released.)

Some students may have already successfully registered at El Camino College (or another community college) previously for a pathway class or for a seminar college class. If so, they will need to know their OpenCCC account information. If students have questions about this, they should talk to their counselor.

Again, please complete all attached forms and have your student bring them to class on **December 3**. Lastly, students must be a US Citizen or have an Alien Registration Number/Visa in order to receive college credits at this time. If this is a concern, please send an email or call the school.
